This Cookie Policy outlines how **TDXC Digital Solutions FZ-LLC** (“TDXC Digital Solutions”), a UAE-registered Free Zone company, uses cookies on our website. It explains what cookies are, why we use them, the types of cookies we utilize, and how you can manage your cookie preferences. What Are Cookies?

Cookies are small text files stored on your device by websites you visit. They allow the website to recognize your device and store certain information about your visit. These files serve a variety of useful purposes: they help our site function properly and securely, improve your user experience by remembering preferences, and let us understand how the site is performing and where it can be improved learn.traliant.com. Cookies **do not** give us access to your computer or any personal information beyond what you voluntarily provide.

How We Use Cookies

TDXC Digital Solutions uses cookies for several key purposes on our site. We use them to enable essential website functionality, to remember your preferences (such as language or other settings), to monitor site performance, and to gather analytics that help us improve our services and content learn.traliant.com. These cookies allow us to provide you with a smoother and more tailored browsing experience, ensuring the website runs reliably and efficiently for you. Importantly, we do **not** use any third-party tracking cookies on our site – this means we currently **do not** utilize external analytics services like Google Analytics or Facebook Pixel for tracking purposes. All cookies used are either necessary for operation or intended for our own analysis and improvement of the site.

Types of Cookies We Use

Our website uses the following categories of cookies (we do not list each cookie by name, but by their purpose):

- **Essential Cookies (Strictly Necessary):** These cookies are crucial for the basic functioning of our website. Without them, core features of the site would not work properly. For example, essential cookies might enable page navigation, secure login, or remembering items in a shopping cart. They do not collect any personal data for marketing and are generally first-party cookies required for service delivery cookie-script.com. (Because these cookies are necessary for the website to operate, they are used without needing your consent under applicable law.)
- **Functional Cookies (Preferences):** These cookies allow the site to remember choices you make and provide enhanced, more personalized features. They may remember your preferences such as language selection, region, or other customizations so that you don't have to reset them on each visit cookie-script.com. Functional cookies improve your user experience by making the website more convenient to use (for example, by keeping you logged in or remembering your display settings). While helpful, these cookies are not strictly necessary and thus will only be set if you consent to them.
- **Performance Cookies:** These cookies collect information about how visitors use our website and how well the site is performing. We use them to understand and analyze key performance metrics, such as which pages are popular, how long users stay on each page, and if any errors occur, so we can improve the website's functionality and fix issues cookie-script.com. The data collected by performance cookies is

aggregated and anonymous – it does not identify you as an individual. Overall, these cookies help us enhance our site's speed, responsiveness, and overall user experience. (Like functional cookies, we will not set performance cookies without your consent.)

- **Analytics Cookies (Optional):** Analytics cookies are used to gain deeper insights into user interactions and usage patterns on our site. For example, they can help us determine which content is most engaging, which pages users visit most frequently, or how users navigate through the site (such as which pages are visited and how long visitors stay on them) investopro.com. This information is **only used to improve** our website and services. Data collected through our analytics cookies is not personally identifiable – we do *not* collect your name, email, or any contact information via cookies. All analytics data is aggregated and anonymous, used solely for statistical analysis and site improvement purposes investopro.com. These analytics cookies are **optional** and will only be deployed with your permission. *Note:* We do **not** currently use any third-party analytics or advertising cookies (such as Google Analytics or Facebook Pixel) on our site, so all analytics data stays within TDXC Digital Solutions' control. If in the future we consider using third-party analytics tools, we will do so only in compliance with this policy and applicable laws, and we will update our policy and obtain your consent as required.

Managing Your Cookie Preferences

You have the right to choose whether to accept or reject non-essential cookies. When you first visit our site, you will see a cookie consent banner that allows you to **accept or decline** different categories of cookies (aside from the essential cookies which are always active). If you consent to optional cookies, you can **change your preferences or withdraw your consent at any time** by revisiting the cookie settings on our website learn.traliant.com. For instance, you may find a "Cookie Settings" link or use the preference center on our site to adjust your choices. Any consent you give for cookies is stored and will be honored on your subsequent visits; if you change your mind, simply update your preferences and our site will respect your new settings.

In addition to our website's own cookie controls, you can also manage or delete cookies through your **web browser settings** at any time. It's quite straightforward to control cookies at the browser level – you can configure your browser to block all cookies, to allow only certain types or from certain sites, or to delete cookies whenever you close the browser carrotcomms.co.uk. You can also remove cookies that have already been set. For detailed guidance on how to adjust cookie settings or delete cookies, consult your browser's help documentation. Many browsers provide specific instructions (for example, Google Chrome, Firefox, Safari, and others have pages explaining how to clear or control cookies). Additionally, you may visit independent resources like **AboutCookies.org** which offer up-to-date instructions for managing cookies in different browsers carrotcomms.co.uk.

Please note: If you choose to disable or block cookies (particularly the essential and functional ones), some parts of our website may not function properly. For example, you might not be able to use certain features, log in, save your settings, or some pages might not display correctly without cookies luckyvoice.com. Essential cookies ensure the core functionality of the site (such as security and network management), so we recommend allowing those for the best experience.

Compliance with Cookie Laws

TDXC Digital Solutions is committed to complying with international privacy and cookie regulations, including the European Union's **General Data Protection Regulation (GDPR)** and the **ePrivacy Directive** (often known as the EU "Cookie Law"). In line with these laws, we ensure that no non-essential cookies are placed on your device without your prior consent en.wikipedia.org. In other words, any cookies that are not strictly necessary for the service of our site are only activated if you have expressly allowed them via our cookie banner or settings. We provide clear and comprehensive information about the cookies we use, and we honor your choices regarding cookie consent, as required by GDPR and the ePrivacy Directive.
